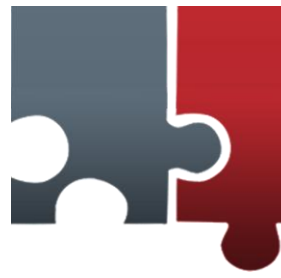

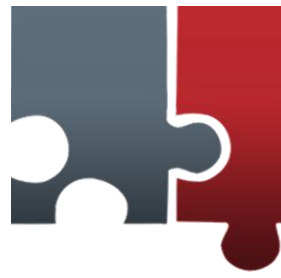

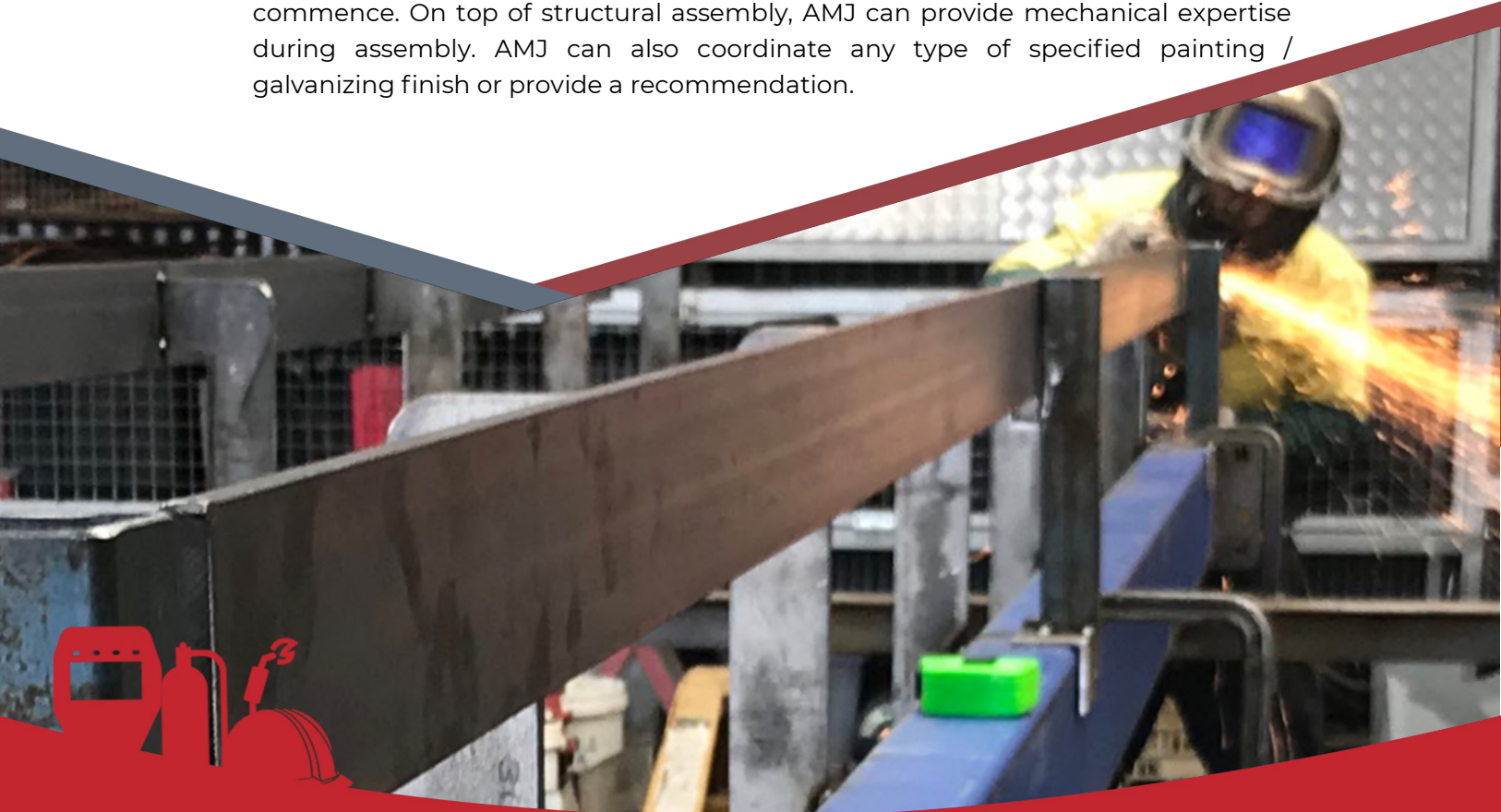
#### **Design and Engineering**

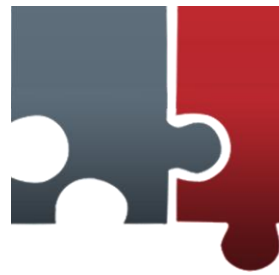


#### **Workshop Assembly and Painting**

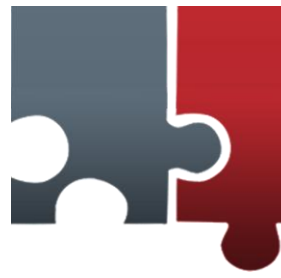

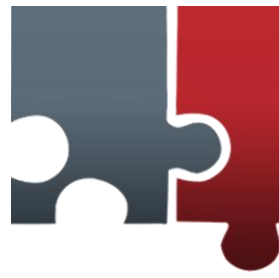

### Managers

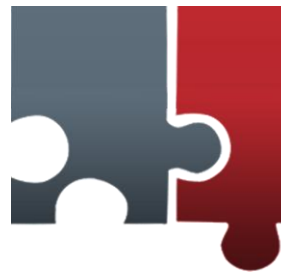

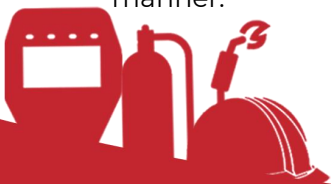
This Environment Policy Statement receives the highest priority from the senior managers of the organisation and this priority is communicated to all personnel connected with the company.

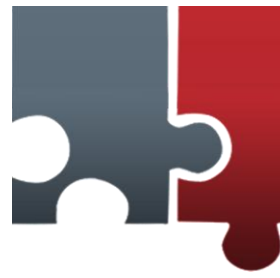
